THIS IS A RELEASE OF LIABILITY, WAIVER OF RIGHTS AND AN AGREEMENT NOT TO SUE. YOU ARE GIVING UP LEGAL RIGHTS BY SIGNING THIS DOCUMENT. THE EXECUTION OF THIS DOCUMENT IS A CONDITION TO ENTERING ONTO THE PROPERTY OF WOMAN'S CLUB ("WC"), AND PARTICIPATING IN FENCING ACTIVITIES WITH KERN ATHLETIC FENCING FOUNDATION, INC. ("KAFF"). READ BEFORE SIGNING.

In consideration of being permitted to enter onto the property of WC to participate thereon in any way with KAFF in the sport of fencing, I on behalf of myself, my heirs, legal representatives, an assigns, hereby acknowledge, appreciate, agree and knowingly assume risks and waive and release all claims related thereto, and agree to indemnify WC and KAFF, all as provided herein.

1. The risk of injury from fencing and all activities associated with fencing and from swords, blades and such weaponry involved is significant and inherently dangerous, including participation in fencing as a participant, a spectator, a coach or an assistant ("Participant"), and while particular protective equipment and personal discipline will minimize this risk, the risk of serious personal injury, property damage and death does exist.
2. I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, and release and hold harmless all of those persons or entities mentioned herein **EVEN IF ARISING FROM NEGLIGENCE** of those persons released from liability below who might otherwise be liable to me (or my heirs or assigns) for damages, and assume full responsibility for my participation; and.
3. I understand that the activities of fencing are physically and mentally intense. I understand the rules and will comply with all instructions, rules, and regulations. If I observe any unusual or unnecessary hazard during my participation, I will bring such to the attention of the nearest instructor as soon as practical; and.
4. I, for myself, and on behalf of my heirs, assigns, personal representatives, and next of kin, **HEREBY RELEASE AND HOLD HARMLESS KAFF, AND ITS INSTRUCTORS, REPRESENTATIVES, PARTICIPANTS, BOARD MEMBERS AND MEMBERS, AS THE OWNER AND LESSOR OF THE PREMISES NORMALLY USED TO CONDUCT FENCING CLASSES AND TOURNAMENTS, (collectively "Releases"), WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, OR LOSS OR DAMAGE TO ANY PERSON OR PROPERTY, WHETHER CAUSED BY THE NEGLIGENCE OF RELEASEES OR OTHERWISE,** including any claims that are known or unknown, foreseen or unforeseen, future or contingent. I shall not now or any time in the future, directly or indirectly, commence or prosecute any action, suit, or other proceeding against the Releases arising out of or related to the actions, causes of action, claims, and demands hereby waived, released, or discharge by me.

I FURTHER EXPRESSLY WAIVE THE PROVISIONS OF CALIFORNIA CIVIL CODE SECTION 1542 WHICH PROVIDES: "A GENERAL RELEASE DOES NOT EXTEND TO CLAIMS WHICH THE CREDITOR DOES NOT KNOW OR SUSPECT TO EXIST IN HIS FAVOR AT THE TIME OF EXECUTING THE RELEASE, WHICH IF KNOWN BY HIM MUST HAVE MATERIALLY AFFECTED HIS SETTLEMENT WITH THE DEBTOR".

5. I understand and agree that this Release of Liability Agreement covers each and every fencing class, tournament and other event in which I participate hereafter, **WHETHER AT THE WC PROPERTY OR AT OTHER PROPERTY WHERE TOURNAMENTS, PRACTICES OR OTHER EVENTS MAY BE HELD FROM TIME-TO-TIME.**

I HAVE READ THIS RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND SIGN IT FREELY AND VOLUNTARILY, WITHOUT ANY INDUCEMENT.

Rules of the Studio

- Good sportsmanship is paramount.
- Respect the fencing coaches and instructors. Fencing is a martial art with traditions that are honored and respected.
- Greet and shake hands with the fencing coaches and instructors upon arrival and departure from the studio, however do not interrupt private or group instructions.
- Salute your opponent.
- Respect the weapons. *Always keep the point down.* Be aware of the point of your weapon so that you do not cause injury to another person. Never point your weapon at an unmasked fencer.
- The studio is a place of work and training where a healthy spirit of camaraderie, discipline, good sportsmanship and learning is to be maintained by all fencers. Be prepared to help club mates when asked. Welcome the newcomer.
- Always remain courteous, polite and well-mannered in the studio. No offensive language.
- Protective fencing gear must be worn while fencing.
- Protective gear must be kept clean and maintained in proper condition for safety and protection. If you notice a problem with club gear, please bring it to the attention of a coach or instructor right away.
- Do not borrow equipment from a club mate without their consent.
- Any borrowed club equipment which is damaged or broken by a fencer will be replaced, repaired or paid for by the same fencer.
- Respect and take care of the studio equipment and property.
- Do not bring food onto the fencing strips or fencing area.
- To maximize your fencing instruction and lesson, arrive early for an adequate warm-up and be ready at the scheduled start time. Late arrivals may take the remaining lesson time or may have no lesson at the discretion of the instructor, and the lesson will be charged as the full lesson.
- Cancellation of the reserved private lesson should be made 24 hours in advance so that another waiting for a lesson time might fill the time slot, and as a courtesy to the instructor.
- Class tuition, floor fees and lesson fees must be current in order for a fencer to receive instruction or to be permitted to use the studio.
- Fencer level placement and participation is at the discretion of the Coach.
